

OfficeTiger and RR Donnelley Sign Definitive Merger Agreement

OfficeTiger Management Team and Strong OfficeTiger Brand to Drive RR Donnelley's Strategic Expansion in Fast-Growing BPO Segment

NEW YORK, March 20, 2006: OfficeTiger and R.R. Donnelley & Sons Company (NYSE: RRD) today announced that the two companies have signed a definitive merger agreement in which RR Donnelley, the world's premier full-service global print provider and business solutions company, will acquire OfficeTiger in an all-cash deal. The transaction brings together OfficeTiger's predominant brand in judgment-based outsourcing solutions with RR Donnelley's existing document-based outsourcing capabilities to create a new global business process outsourcing (BPO) leader. This combined group will bring to bear well over 5,000 professionals across dozens of facilities in the US, UK, Continental Europe and Asia with services spanning research, analytics, accounting, paralegal support as well as RR Donnelley's historic strength in transaction and document processing.

As part of RR Donnelley, OfficeTiger will leverage its pool of world-class talent and experienced management team to drive RR Donnelley's strategy to expand in the fast-growing, higher-return BPO segment. OfficeTiger will continue its current operations as an independent business unit of RR Donnelley, maintaining the strong OfficeTiger brand.

"We are proud to welcome OfficeTiger to the RR Donnelley family," said **Mr. Mark A. Angelson, RR Donnelley's Chief Executive Officer**. "The addition of OfficeTiger is a major step forward in our strategy to build a global BPO business. We expect OfficeTiger's superb judgment-dependent services, including financial management, research and analytics, marketing-related offerings and other knowledge-based capabilities to lead our growth in this exciting segment."

"This is a good fit and a compelling strategic opportunity for both companies. The transaction reflects our companies' shared vision to drive expansion in the fast-growing BPO segment," said **Mr. Randolph Altschuler, OfficeTiger's Co-Chief Executive Officer**. "With this combination, our customers will have access to the best talent and resources in the outsourcing industry from across the world, all under one roof. OfficeTiger is going to help build an exceptional provider of white-collar judgment-based professional services. Together, we are an even more formidable competitor in the offshoring industry. As a key strategic division of RR Donnelley, we will continue to be a driving force for our sector and to create new opportunities for our business, our customers and our highly valued employees."

"We believe this partnership represents a strong statement on the consolidation of an evolving industry," said **Mr. Joseph Sigelman, Co-Chief Executive Officer of OfficeTiger**. "As part of a multi-billion dollar institution backed by world-class infrastructure, best practices and support services, OfficeTiger will have enhanced opportunities to realize its full potential for growth. We see the combined OfficeTiger-Astron platform in the BPO space as defining a hybrid onsite-offshore solution that covers the US as well as Europe with a local presence on the ground. We will be adding to OfficeTiger's strength in banking, publishing, legal and corporate customers, Astron's government, credit card and insurance clientele."

The transaction is subject to regulatory approval and is expected to close in the second quarter of 2006.
